The Hamilton Sirius Fund is an Australian investment fund that holds a relatively concentrated portfolio of investments for the long term.

The fund seeks to identify investments whose underlying value is not reflected in their market price. The undervaluation may arise from any number of factors including market failure to recognise advancements in technology, competitive advantages, market changes, or simply shareholder apathy. The fund can hold cash while waiting for suitable investment opportunities to arise.

The fund is managed without regard to any market benchmark or index.

The fund will be closed once it reaches a capacity where we believe further growth will limit its investment opportunities and result in constrained returns for our investors.

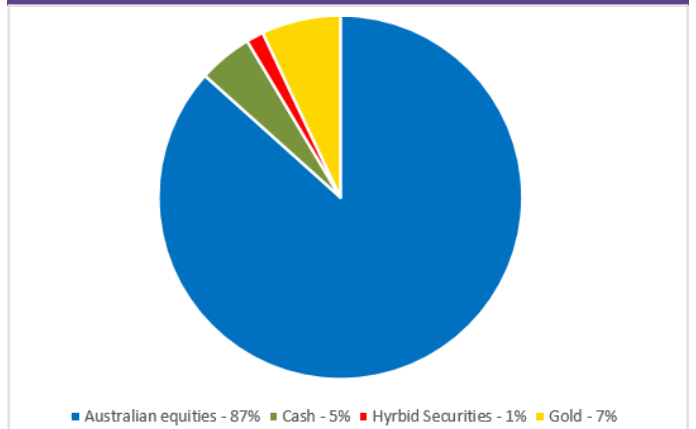

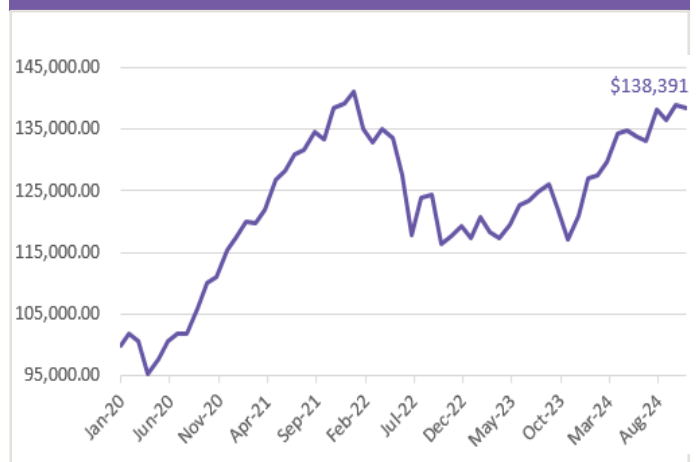
Asset allocation as at 31 October 2024
